#### Notes

#### 1 Income

Budgeted Practice Fees is the estimated 2019 practice fees from renewals plus a proportion of the estimated amount for admissions of attorneys during the year.

Budgeted Other Income is only in respect of bank interest. As the number of applications in respect of role holder positions and licensed bodies are outside our control, as per our usual practice, we do not include a figure for them in the budget.

## 5 Financial Costs

The largest component of the Financial Expenses budget line relates to commission and charges on card transactions. The number and value of card transactions is significantly higher than in previous years.

## 6 Regulatory Officers
